During his career, Mark has served on the boards of four public companies in which he has been a substantial shareholder. Mark has an MA in History from Cambridge University.

Fund Objective

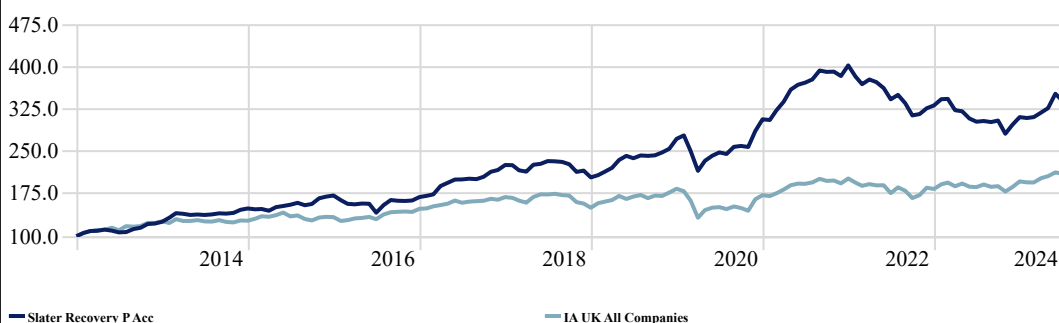

It is also intended where appropriate to take advantage of underwritings and placings.
